Mill Street Loft celebrates its 30th Anniversary on Thursday, March 4, 5:30 pm at the Poughkeepsie Grandview at its annual Friend of the Arts Award event. To celebrate this momentous occasion, Mill Street Loft is hosting a Juried Arts Show of 30 Top Hudson Valley Artists to be showcased for a Silent Auction. This work will represent the diversity and quality that is produced by Hudson Valley area artists and supported by the Mill Street Loft for the past 30 years.

Jurors: Steven Evans, Linda T. Hubbard, Sarah Levine

Steven Evans is Dia Art Foundation's Assistant Director for Beacon, overseeing Dia:Beacon Riggio Galleries. Over the last two decades, he has worked extensively with Dia artists and colleagues to realize many outstanding contemporary art projects. In addition to his duties at Dia, Evans is a curator, artist and writer. His 2009 curatorial project Other Voices, Other Rooms at Dorsky Gallery Curatorial Programs was recognized by an International Art Critics Association/AICA award.

Linda T. Hubbard is a photographer and co-owner of RiverWinds Gallery in Beacon.

Sarah Levine is a filmmaker and art collector.

Notification and Delivery

Artists juried into the show will be notified of acceptance and delivery information on Wednesday, February 10, 2010. Artists must confirm their acceptance by February 17, 2010.

Exhibit Dates and Location

Works will be exhibited on the Mill Street Loft Website Gallery February 19 - March 4, 2010 and at the Event March 4, 2010 4pm - 7:30 pm at the Poughkeepsie Grandview, Poughkeepsie, NY.

Work For Sale

All works must be for sale. The artwork will be part of a Silent Auction to benefit the Mill Street Loft. 50% of the proceeds will go to the artist and 50% to the Mill Street Loft. For the Silent Auction, artists should state a minimum starting price, but no higher than 50% of the retail value of the work. Artwork will be for sale at the full price on the Mill Street Loft website starting February 19th at 9am with a noon cutoff on March 4th. At the Event on March 4th, the Silent Auction will begin at 4pm until 7:30pm.

Insurance

Artists are responsible for the insurance for their artwork. The Mill Street Loft or the Poughkeepsie Grandview will not be held responsible for any damage or theft.

Delivery and Pick

All works must be delivered to the Poughkeepsie Grandview by noon on March 4th or arrangements made with the Mill Street Loft for an earlier delivery to Mill Street Loft, 45 Pershing Ave.

Work not sold should be picked up that night - or arrangements made with the Mill Street Loft.

Submission Requirements

1. You may submit images for up to three (3) individual works.
2. All entries images must be digital: 72 dpi and nothing greater than 1200 pixels in either direction. Jpeg files preferred and include your name as part of the file name. They may be on a CD and mailed, or delivered to Mill Street Loft, 45 Pershing Ave, Poughkeepsie, NY 12601 or they may be emailed to info@millstreetloft.org with the heading MSL Juried Art Show 2010.
3. In addition to the 3 images, please list the artist name, number, title, dimensions, medium and retail price and include a one page artist statement. Please label MSL 2010 Juried Show
4. Do NOT send original artwork, slides or photos for the selection process.
5. All two dimensional work must have necessary hanging hardware attached to the piece.
6. If mailing a CD, please include a SASE for return of materials.
