The Barrett Art Center/Dutchess County Arts Association invites you to participate in their "Art of the Garden" art exhibition and sale scheduled for Saturday, March 13th – Saturday, April 3rd. **All works must be for sale for this special exhibition.**

Painters, watercolorists, pastel and drawing media artists, photographers, printmakers, collage, textile and mixed-media artists: All framed works must be wired and ready for hanging. Matted works for our bins should be protected by plastic. A label with your name, item number and selling price must be placed on the back of each work. "Art of the Garden" is a theme show. Botanicals, floral, fruit & vegetable still-life works, garden, wildlife scenes and landscapes would be appreciated.

Ceramicists, potters, glassmakers, sculptors, basket makers, bird house makers, jewelers and 3-D mixed media artists: Pottery, vessels, vases and garden objects of all kinds will be accepted for this show. A label with your name, item number and price must be placed on each work and attached to each jewelry piece.

Art Work	Up to four pieces will be accepted from each artist. <u>All works must be for sale. Smaller works and works with a selling price of \$200 or less are requested. 9" x 12" (frame size) works or smaller are suggested.</u> Maximum framed size is 16" x 20".
Art Work Delivery Dates	Thursday and Friday March 4 th and 5 th from 11:00am – 5:00pm, on Saturday, March 6 th from 11:00am – 3:00pm or at other times by appointment.
Terms of Sale	60% of the selling price is due to artist members, a 40% commission is due to the BAC. The commission is 50% artist - 50% BAC for non-members. Please consider this commission when pricing your work.
Pre-Registration/Entrance Fee	Enclosed is your registration form. Please bring it with you when you deliver your work. There is a registration fee of \$15.00 per artist (to off-set printing, advertising, postage and the opening reception).
Publicity	If you have a photograph of the art-work you will be submitting, or of yourself working on your art, please e-mail the photos to us at info@barrettartcenter.org - we may use them for publicity!
Retrieval Dates for Unsold Work	Thursday and Friday April 8 th and 9 th from 11:00am – 5:00pm, on Saturday, April 10 th from 11:00am – 3:00pm or at other times by appointment.
Payment to Artists	Payment is due to the artist within 3 weeks after the close of the show. As a courtesy to participating artists, buyer's names & addresses will be included with payments for your mailing lists.
