SUBMISSION PROCEDURE

FILM: Send 35mm slides (2" x 2") of art work in paper or plastic mounts (no glass or adhesive labels) in a plastic slide sheet or holder. On the side of the slide that the work is to be viewed, clearly indicate the following: **Artist's Name, Title, Medium, Dimensions, and Date.** Indicate **TOP** and **assign the slide a number** to correspond with the number on the entry form.

DIGITAL: CD with your images (not DVD). **NO ASTERISKS OR QUOTES. Simple titling. Artist LAST name FIRST, then title, size, medium. JPG's ONLY.** Approx. **1mb jpg file is sufficient.** (A good pixel width of 1800 sufficient for detail) **CD'S MUST OPEN ON PC's & Macs.** Please test before sending. Unreadable CD's will not be judged. Judging will be done from slides or CD's only, **no prints of any type** accepted. Work previously exhibited at the DCAA/Barrett Art Center is not eligible. Submitted work must have been completed within the last 4 years.

ENTRY FEE

Entry fee is non-refundable. \$30.00 for the first 4 slides or images, \$6.00 for each additional image (please use the back of this form or additional paper if needed). Complete the enclosed entry form, and send it to the BAC along with your slides or disk and entry fee so that it arrives at the BAC no later than Saturday, February 14th, 2009.

NOTIFICATION OF ACCEPTANCE OR REJECTION

Please remember to include a self-addressed, stamped envelope for notification of acceptance or rejection and the return of your slides or CD. **Every precaution will be taken to assure the safe return of your materials, but the BAC cannot be responsible for any loss or damage.** Care should be taken that images are **accurate representations** of your work. **Accepted works that do not reasonably meet the quality indicated in the slides can be refused.** Accepted work will **require proper framing or presentation, no** substitutions of accepted work will be permitted. Slides and images of accepted works may be retained by Barrett Art Center for publicity and documentation purposes. **If selected, instructions for submission of artwork will also be forwarded to the entrant.**
